West Bengal State Health & Family Welfare Samiti will engage personnel for the position of **State Consultant (Climate Change)** as mentioned below under **National Health Mission**, Department of Health and Family Welfare, Government of West Bengal purely on contractual basis.

**The applicant must be a permanent resident of West Bengal.**

**The applicant must have knowledge of local languages.**

Eligible candidates should apply online in the prescribed format as given in Department's Website from 11 am of 24<sup>th</sup> July, 2024 to **Midnight 7<sup>th</sup> August, 2024** for the mentioned position.


