West Bengal State Health & Family Welfare Samiti will engage on contractual basis against subsequent vacancy for the position of **State Entomologist - NVBDCP** in **National Vector Borne Disease Control Programme (NVBDCP)**, under National Health Mission, Department of Health and Family Welfare, Government of West Bengal and will be posted at State Head Quarter.

The applicant must be a permanent resident of West Bengal.

The applicant must have knowledge of local languages.

Eligible candidates should apply online in the prescribed format as given in Department's Website **from 11 am of 15th July, 2024 to Midnight of 29th July, 2024 for the mentioned position.**

Annual increment will be applicable for these new contractual employees from financial year 2025-26.
 11. The candidates, **if found ineligible/absent** at any stage of recruitment process, will not be called for the subsequent stages of the selection process.
