West Bengal State Health & Family Welfare Samiti will engage personnel for the position of **State Consultant-Family Planning Logistics Management Information System** as mentioned below under **National Health Mission**, Department of Health and Family Welfare, Government of West Bengal purely on contractual basis.

The applicant must be a permanent resident of West Bengal.

The applicant must have knowledge of local languages.

Eligible candidates should apply online in the prescribed format as given in Department's Website from 11 am of 22nd July, 2024 to Midnight 5th August, 2024 for the mentioned position.

Only online applications will be accepted. Application forms not properly filled in or incomplete application forms are liable to be cancelled. Application fees of ₹100/- have to be deposited through on-line mode only. The amount is non-refundable (Details of on-line mode, payment details and important dates are given in General Information point no. 8 & 9).

Essential Criteria : Candidate must have degree from any University or Institution recognised by UGC or AICTE on following:

- a) B.Tech (IT) /M.Sc in Computer Science/Master of Computer Application /M.Sc. in Statistics
- b) Minimum 2 years post qualification experience in Government or Private Sector in handling information system, data analysis and reporting.
- c) Proficiency in computer application including knowledge of MS Office.
- d) Excellent communication skill.
- e) Ability to work in mission mode.

Age (as on 01.01.2024) : Minimum 21 years and Maximum 40 years

MODE OF SELECTION : Candidates will be called for computer test and interview on the basis of score of essential criteria. Qualifying Marks for computer test is 50%, after which the candidates will be eligible for further steps of recruitment.

Final selection will be made on the basis of total marks obtained in computer test, interview and score on essential criteria.


