
1. Candidates will be called for Computer Test and Interview on the basis of score of essential criteria.
2. **Qualifying Marks for Computer Test is 50%.**
3. Candidates qualified in computer test will be called for interview.
4. **Final Selection will be made on the basis of total marks obtained in Computer Test, Interview and score on essential criteria**

General Information for the Applicants/Candidates

1.
